# 1. Welcome

Chairman Aled Morris Jones welcomed the group.

#### 2. Introductions and apologies

Apologies were received from Angharad Crump and Debbie Jones.

# 3. Minutes

Minutes from the previous meeting were approved by the group.

### 4. Project update

Mark Reynolds presented the following construction updates:

- Piling and excavation are continuing.
- Trenching and PV array cabling installation are ongoing.
- Transformer stations to be delivered by the end of the year.
- Substation works nearing civil completion with grid transformer being delivered and installed.
- 4<sup>th</sup> April set for first energisation.
- Local contractors JBC have commenced work with Grupotec using local labour.
- A noise complaint was received from a local resident. This was deemed to be in line with planning conditions. EDF Renewables will work with the resident in question when the tree



planting strategy is defined in order to further enhance buffering around her property.

### 5. Community Benefit Fund (CBF)

- Kerry fed back to the group that EDF Renewables would not be adding £2k per annum to the CBF. The reason for this was that the fund has already been doubled from £10k to £20k. The group have requested this be revisited. Kerry has asked that the group submit in writing a proposal for additional monies requested.
- A request was made that the group reconsider the intended spend of ringfenced schools monies and streams other than just Welsh Language. The group have decided that ringfenced money should be spend on Welsh language alone and will write to schools to inform them of this.

#### 6. AOB

- Future meetings should be held at Cemaes Heritage Centre.
- Translated wording on some signage is incorrect. Mark Reynolds to review via Grupotec and ensure Welsh translations are accurate and Welsh appears above English consistently.

#### 7. Actions

- CLG to submit in writing request for funding above the CBF and a framework for intended spend.
- Kerry & Mark to provide more in-depth insight to local contractors and employment realised on Anglesey as a result of the project.
- CLG to write to two local schools to inform them of their preferred spend of CBF.
